

Sub: Establishment of an additional Krishi Vigyan Kendra at Village-Rourkela Town Unit No.2 (Bankia) P.S.-Raghunathpolli, Tehsil:Rourkela, Sundergarh District of Odisha.

Sir

I am directed to convey the sanction of the Indian Council of Agricultural Research (ICAR) for the establishment of an additional Krishi Vigyan Kendra at Village- Rourkela Town Unit No.2 (Bankla) P.S. Raghunathpalli, Tehsil:Rourkela, Sundergarh District of Odisha with 20 ha. of land in favour of Oissa University of Agriculture & Technology, Bhubaneshwar, Odisha under the Plan scheme of the Council. The Council's share of assistance will be on cent per cent basis.

- 2. The additional KVK to be established at Village-Rourkela Town Unit No.2 (Bankla) P.S.-Roghunathpalli, Tehsil-Rourkela, Sundergarh District of Odisha under the administration control of Oissa University of Agriculture & Technology, Bhubaneshwar. The additional KVK shall cater to the technological needs of farmers in Eight Blocks namely Nuagaon, Bisra, Kuarmunda, Lathikata, Guundia, Banai, Koira and Lephripara out of 17 blocks while remaining Nine Blocks namely Ballankar, Subdega, Kutra, Bargaon, Tangarpall, Lephripara, Hemgir, Sundergarh and Rajgangpur rings be covered by the existing KVK located at Kirei, Sundergarh district of Odisha under the administrative control of Orissa University of Agriculture & Technology, Bhubaneshwar.
- The detailed terms and conditions governing the grant-in-old are appended as Annexure-I.
 The proformae for audit utilization certificate are enclosed as Annexure-II and III.
- A list of posts sanctioned for the Krishi Vigyan Kendra is enclosed as Annexure-IV. The pay scales indicated in Annexure-IV are as applicable to KVKs under ICAR Institutes. The Programme Coordinator in the KVK under the SAU will be extended Pay Scale as applicable to Senior Scientist in ICAR. The scales of pay of all other staff in the KVK are to be decided by the University [Grantee Institution). The liability of ICAR towards payment of pay and allowances will, however, be limited to pay scales as for KVKs under ICAR Institutes, as indicated in Annexure IV, or actual whichever is less. The recruitment process may be initiated early following the guidelines of the Council with regard to pay scales/disciplines/qualifications of the posts in consultation with the Zonal Project Director, Zonal Project Directorate, Zone-VII, JNKVV, P.O. Adhartal, Jabalpur, Madhya Pradesh. All relevant guidelines in the matter may be obtained from the Zonal Project Director, Zonal Project Directorate, Zone-VII, Jabalpur.
- Approval of the Council is to be obtained for the master lay-out and plan and estimate of buildings and demonstration units before taking up construction work as per norms of plinth area for different buildings and from the Zonal Project Director, Zonal Project Directorate, Zone-VII, Jabalpur.
- The exact date of start of the scheme may please be intimated for information and record in the Zonal Project Directorate, Zone-VII, Jabalpur concerned as well as to the undersigned.
- 7. Demand of fund may please be submitted to the Council in the prescribe proforma on half yearly basis through the concerned Zonal Project Directorate, Zone-VII in April and October every year. All correspondences to this Division may be made through the Zonal Project Director, Zonal Project Directorate, Zone-VII, Jabalpur.
